PAYMENT

CANCELLATION / RESCHEDULING

If cancellation or rescheduling is necessary, please give us a minimum of 24 hours notice via email, otherwise a €50 minimum charge will apply.

If appointments are cancelled within an hour of the 3D virtual tour recording or if the site is not ready to be photographed / filmed upon arrival, the full amount of the 3D virtual tour recording will be charged.

The Client (you) shall pay all expenses incurred up to the time of the cancellation.

SITE PREPARATION

It is essential that the site is prepared for the 3D virtual tour recording appointment and ready upon the arrival of the Sphereshot representative.

We have created a 3D Tour Recording Preparation Checklist - you can use this as a guide to prepare the site. Unless otherwise arranged with the Sphereshot representative, a site that has not been prepared will not be recorded and must be rescheduled.

If the site is not prepared for the 3D tour recording when the Sphereshot representative arrives, as per the 3D Virtual Tour Recording Preparation Checklist, then the Sphereshot representative may choose to wait until the site is ready. Waiting or cleanup and staging assistance time, if available, is charged at €70 per hour or portion thereof and added to the invoice.

ONSITE SERVICES

The 3D tour recording will typically take between 45 minutes to 4 hours depending on property size.

There must be no persons on site during the 3d virtual tour recording session. Please do not book showings or other appointments during the 3D virtual tour recording session. Delays incurred on-site

falling outside the scope of work required by a Sphereshot representative will be billed to you at €70 per hour.

DELIVERY

Images and virtual tours are typically available between 24 and 48 hours after the 3D virtual tour recording. The images are edited and optimized for quality before delivery to You. An email will be sent from sphereshot.co containing a link and an embed link of the 3D recording together with the final invoice.

For more complex 3D virtual tour recordings in need of more thorough engineering, Sphereshot reserves the right to deliver the 3D virtual recording at a later time of it's choosing without any consequences to the initial agreement between You the Client and Sphereshot.

ADDITIONAL FEES

Travel – Sphereshot is located in the Rotterdam Science Tower. Extra fees may be applied for all projects outside a 50 k.m. radius of Rotterdam. If a travel fee applies to your project, it will be included in your estimate.

Tolls - A toll fee/s may be applied to your invoice if the Sphereshot representative has to incur this expense if travelling to your listing. If a toll fee applies to your listing, it will be included in our estimate.
